



Project Seagrass: Coldplay Ticket Competition Terms and Conditions 2025

1. By entering the competition you are confirming that you have read and agree to the terms and conditions of the prize draw.
2. The prize draw is being run by Project Seagrass, Registered Charity in England and Wales No. 1162824 and in Scotland No. SC046788 and registered office at Unit 1 Garth Drive, Brackla Industrial Estate, Bridgend, CF31 2AQ, United Kingdom
3. The tickets have been donated to Project Seagrass by our patron Coldplay in order to support the charity's aim to save the world's seagrass.

Eligibility to enter

4. Entrants must be aged 18 or over.
5. In entering the competition, you confirm that you are eligible to do so and eligible to claim any prize you may win.
6. A maximum of 1 entry per individual is permitted.
7. The prize draw is free to enter.
8. 5 pairs of tickets are available and 5 winners will be determined as part of the draw.
9. Project Seagrass staff, family members, trustees and associates are not eligible to enter the competition.

How to enter

10. To enter the competition:
 - (i) Produce a creative design communicating one of the following 5 themes:
 1. The importance of seagrass

2. Seagrass and people
3. Seagrass around the world
4. Seagrass at risk
5. Seagrass life

(ii) Submit your entry via the entry form.

11. Entries must be received between 10:00 (GMT) Monday 13th January 2025 and 23:59 (GMT) Sunday 16th February 2025. Entries received before or after this time will not be eligible for consideration.

12. The winners will be chosen by a panel of judges from Project Seagrass, Coldplay Management Team and at least one independent judge. Full names of the judging panel will be available on request. Any decision will be final and binding and no further communication will be entered into in relation to it.

13. Ownership of entries:

The 5 winners' artwork will be used by Project Seagrass in the future.

By participating in the competition you grant Project Seagrass a non-exclusive, irrevocable, perpetual, world-wide, royalty free license to publish, edit, display, use, transmit, make available, distribute and store your entry in whole or in part for any purpose and in all media formats whether now known or devised in future (including without limitation on websites and social media channels).

You confirm that: (i) your entry is your own original work and no other person was involved in its creation; (ii) AI has not been used to create your design (iii) your entry is not defamatory and does not infringe any applicable laws, or any rights of any third party, (iv) you have the right to give Project Seagrass permission to use your entry for the purposes specified herein; (v) you have the consent of anyone who is identifiable in your entry or the consent of their parent, guardian or carer if they are under 18; and (vi) it is lawful for you to enter.

Only the 5 winners' artwork will be used by Project Seagrass in the future.

The prize

14. Five pairs of tickets are available to win as prizes. One pair of tickets will be awarded per winner (one winner per category). Each prize consists of one pair of general admission, standing tickets to see Coldplay at Wembley Stadium, London, UK as part of the 2025 Music Of The Spheres World Tour. 18. The decision of Project Seagrass regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.

Winner announcement

19. The 5 winners of the competition shall be notified as follows: the 5 winners will be contacted via the contact details provided with their entry on Monday 24th February 2025.

20. Project Seagrass will attempt to contact the winner up to two times.

21. Project Seagrass will not accept responsibility if contact details provided are incomplete or inaccurate.

22. If the winner does not respond to the attempts to notify them of their win within 14 days of the second attempt, they will lose their right to the prize, and Project Seagrass reserves the right to choose and notify a new winner.

23. The 5 winners will subsequently be announced publicly via Project Seagrass' social media channels on World Seagrass Day (Saturday 1st March 2025)

Receipt of the prize

24. Ticket and venue information will be distributed via email no later than 24 hours prior to the selected show date.

25. You consent to any personal information you provide in entering the prize draw being used by Project Seagrass for the purposes of administering the prize draw.
